SUMMARY OF DETAILS: PMRPD was dispatched to the Hotel M for the report of an assault involving a knife. Upon arrival Officers found an adult male victim with several injuries. It was determined that the suspects, later identified as Alexis Clark and Shaun High, left in a vehicle prior to police arrival. The victim reported that he arrived at the hotel room of Alexis Clark, and upon entering the room he was assaulted by Clark and High. He also reported that High produced a knife and threatened to stab him during the assault. The victim was transported to St Luke's Hospital for treatment. A description of the vehicle was given out and the vehicle was located by Officers from Pocono Twp PD, who initiated a traffic stop on the vehicle. A search of the vehicle yielded (2) knives, as well as marijuana and drug paraphernalia. High and Clark were taken into custody and transported to PMRPD headquarters where they were booked and processed. They were then taken to the Monroe County Correctional Facility.
