SUMMARY OF DETAILS: On November 23, 2017 at 1445 hrs, Pocono Mountain Regional Police conducted a traffic stop on a Jeep Liberty at the Pen Mart in Pocono Pines. The driver, John Ehrhard was found to be in possession of several grams of crack cocaine. Narcotics K9 Creed, located another larger bag containing crack cocaine inside of the vehicle. Further investigation showed that John was delivering crack to a customer in the Pocono Pines area. Police then conducted a search of John's residence which revealed a large amount of cocaine and evidence of cooking cocaine into crack along with drug trafficking evidence, including scales, baggies and US currency. Ehrhard was arrested and charged with Possession with intent to deliver cocaine.
