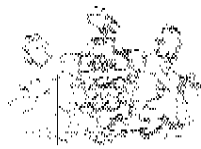

SUMMARY OF DETAILS: On August 25, 2020 Pocono Mountain Regional Police were dispatched to try and make contact with a stolen car that was parked at the Kalahari Resort. Officers were able to find the vehicle in the lot, security was then contacted and a video trace of the suspects led police to a room at the resort. Once at the room Officers waited for the suspects to return to the room before checkout. All above suspects were taken into custody at the resort and a search warrant on the room later found the keys to the stolen car along with drugs and drug paraphernalia. All suspects including the two juveniles were placed in jail.
